- 5. Scholarship funds may be utilized for:
 - 1. Tuition and school fees
 - 2. Books required for course
 - 3. Registrations
- 6. Scholarship award must be used within one year from the date of the award letter and check is received.
- 7. Scholarship awards will be sent directly to the educational institution and require proof of registration, course names and an invoice issued by the institution or the applicants employer.
