# TEXAS CHAPTER SCHOLARSHIP PROGRAM

The Texas Chapter of the Fleet Professionals Association (FleetPros) is proud to present the guidelines and requirements for our Scholarship Program. The total dollar amount available to award is \$4,000.00 per year (two \$1,000 scholarships each Spring and Fall). We feel that this will assist many of our members and/or future members in furthering their education. Scholarships are awarded for the advancement of education in automotive/heavy equipment technology, fleet management and fleet certification.

The Fleet Professionals Association is a non-profit professional organization dedicated to the advancement of the fleet management industry. To apply for a scholarship, applicants must complete all sections of the application, include requested documentation and submit before the deadline date. Scholarship applications are available online at <http://www.rmfm.org/>, or by contacting the Texas Chapter Vice-Chair.

## SCHOLARSHIP GUIDELINES

- A. Scholarship value: various requested increments.
- B. Application deadline: April 15 (for Fall Semester) /October 15 (for Spring Semester), each year.
- C. Announcement of awards will be at the May Quarterly meeting and either the November Texas Equipment & Technology Show or the November Quarterly meeting.
- D. Scholarships will be awarded for continuing education courses in the fleet industry, fleet management, and fleet certification programs within the State of Texas:
  - a. Accredited community college, college or university.
  - b. Automotive technical college.
  - c. FleetPros CAFM/CAFS Management Certification Program.
- E. Scholarship funds may be utilized for:
  - a. Tuition and school fees.
  - b. Books required for course.
  - c. Registrations
- F. Scholarship award must be used within one year from the date of the award letter.
- G. Scholarship awards will be sent directly to the educational institution and require proof of registration, course names, and an invoice issued by the institution.

## REQUIREMENTS

- . Letter of recommendation from an instructor (if applicable) and employer.
- . Copies of any Fleet related awards or certificates.
- . If training and or certification completion is at a future date please submit documentation. *the last word*
- . Completed application.
